

In accordance with 807 KAR 5:056, this filing is being made 10 days in advance of the fuel adjustment factor's anticipated effective date of March 1, 2026.

Due to the extremely cold weather in January 2026, and consistent with the anticipated passage of Senate Bill 172, the Kentucky Fuel Surcharge Stability Act, EKPC is applying a FAC factor cap of .02000, which is 38.5% lower than the actual fuel factor of .03249, to minimize the negative impact to our members, and ultimately end use consumers. The temporary cap will remain in effect until EKPC has recovered the January fuel costs.
