- (3) c. Any party shall make timely amendment to any prior response.
- (3) d. For any request a party fails to furnish the requested information, that party shall provide a written explanation.
- (4) Any party filing testimony shall file an original and 10 copies with the Commission with copies to all parties of record.
- (5) Grayson shall give notice of the hearing in accordance with the provisions set out in 807 KAR 5:011, Section 8(5).
- (6) At any public hearing, neither opening statements nor summarization of direct testimony shall be permitted.
- (7) Any objections shall be filed upon four business days' notice.
- (8) Motions for extension of time with respect to the schedule shall be made in writing.
- (9) Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
