Grayson District is directed to add a provision to its tariff indicating that an inspection on a new or replacement service line must be performed by a local or state inspector unless exempt under KRS 318.015(3). In exempt cases, the customer may choose to have Grayson District or Local/State inspector perform the inspection. 3. Within 20 days of the date of entry of this order, Grayson District shall file with the Commission, using the Commission's electronic Tariff Filing System, its revised tariff sheets setting forth the rates and modifications approved or as required herein, and reflecting their effective date and that they were authorized by this Order. 4. All other ordering paragraphs of the December 14, 2021 Order remain in effect.

Grayson District shall use the midpoint of the depreciable lives of the National Association of Regulatory Utility Commissioners ranges, as proposed in the application and agreed upon by Staff, to depreciate water plant assets for accounting purposes in all future reporting periods. No adjustment to accumulated depreciation, or retained earnings should be made to account for this change in the accounting estimate. 6. This case is closed and removed from the Commission's docket.
