12/09/24 Order Entered: 1. This case is opened to monitor Powell's Valley District's Water Loss Reduction Surcharge proceeds and collections. 2. The record of Case No. 2023-00387 is incorporated by reference in this proceeding. 3. Within 120 days of the date of service of this Order, Powell's Valley District shall file with the Commission a qualified infrastructure improvement plan, including a comprehensive unaccounted-for water loss reduction plan that establishes priorities and a time schedule for eliminating each source of unaccounted-for water loss and provides a detailed spending plan for the proceeds of a surcharge. 4. Powell's Valley District shall deposit surcharge collections in a separate interest-bearing account. 5. On the 15th day of each month for 48 months from the date of service of this Order or until all surcharge proceeds are expended, Powell's Valley District shall file, into this proceeding, a monthly activity report that includes a statement of monthly surcharge billings and collections using the Surcharge Reporting form, a monthly surcharge bank statement; and a list of all payments made for the month from the surcharge account that includes the following for each payment: the payee, a description of the purpose, and the supporting invoice.
