Kentucky Power's determination that it had no additional over- or under-recovery for the six-month billing periods ended December 31, 2023, June 30, 2024, and December 31, 2024, is approved. 2. Kentucky Power shall use a weighted average cost of capital of 6.79 percent, a tax gross-up factor of 1.339896, a return on equity rate of 9.65 percent, and an overall grossed-up return of 8.16 percent in all monthly environmental surcharge filings subsequent to the date of this Order. 3. The environmental surcharge amounts determined by Kentucky Power for the six-month billing periods ended December 31, 2023, June 30, 2024, and December 31, 2024, are just and reasonable. 4. This case is closed and removed from the Commission's docket.

- 03/05/25 Order Entered: 1. This proceeding is initiated to review Kentucky Power's environmental surcharge for the billing periods set forth in this Order. 2. The procedural schedule set forth in Appendix A to this Order shall be followed. 3. On or before the date set forth in the procedural schedule, Kentucky Power shall file its responses to the information requested in Appendix B attached to this Order. 4. Kentucky Power shall respond to any additional requests for information propounded by Commission Staff as provided in those requests. 5. Unless otherwise ordered by the Commission, the procedures set forth in 807 KAR 5:001, Section 8, related to the service and electronic filing of papers shall be followed in this proceeding. 6. Any party filing a paper with the Commission shall file an electronic copy in accordance with the electronic filing procedures set forth in 807 KAR 5:001, Section 8. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked. The Commission directs the parties to the Commission's July 22, 2021 Order in Case No. 2020-00085 regarding filings with the Commission. 7. If a party objects to the use of electronic filing procedures and the Commission determines that good cause exists to excuse that party from the use of electronic filing procedures, service of documents on that party and by that party shall be made in accordance with 807 KAR 5:001, Section 4(8).
