Within 20 days of the date of the entry of this Order, Farmers RECC shall file with the Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and reflecting its effect date and that it was authorized by this Order. 6. Within 60 days of the date of service of this Order, Farmers RECC shall refund to its customers all amounts collected for service rendered after January 1, 2026, through the date of entry of this Order that are in excess of the rates set forth in Appendix B attached to this Order. 7. Within 75 days of the date of service of this Order, Farmers RECC shall submit a written report to the Commission in which it describes its efforts to refund all monies collected in excess of the rates that are set forth in Appendix B to this Order. 8. This case is closed and removed from the Commission's docket.
