Within 20 days of the date of service of this Order, Farmdale District shall file with this Commission, using the Commission's electronic Tariff Filing System, new tariff sheets setting forth the rates and charges approved herein and their effective date, and stating that the rates and charges were authorized by this Order, including the additional multiple meters on one residence language included above. 5. The Commission denies the Water Loss Reduction Surcharge proposed in this proceeding; however, Farmdale District may request a Water Loss Reduction Surcharge in a future tariff filing or other appropriate proceeding, consistent with the recommendations contained in Staff's Report. 6. This case is closed and removed from the Commission's docket.
