All other provisions of the Commission's September 12, 2025 Order that are not in conflict with the terms of this Order shall remain in effect.
- 09/12/25 Final Order Entered: 1. The purchased water adjustment factor of \$0.16 per 1,000 gallons is approved. 2. The rates proposed by Breathitt District are approved. 3. Breathitt District shall refund/credit customers for any amount collected for the period beginning July 1, 2025, up to and including, July 29, 2025. 4. Breathitt District shall file proof of refund/ credit as well as the amount of the refund/credit in post case correspondence referencing this case number no later than 90 days. 5. The rates as set forth in Appendix B to this Order are approved for water service rendered by Breathitt District on and after July 1, 2025. 6. Within 30 days Breathitt District shall file the revenue sufficiency report as ordered in Case No. 2024-00215. 7. Within 20 days of the date of service of this Order, Breathitt District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein. 8. On or before August 31, 2026, Breathitt District shall file an application for a general rate adjustment pursuant to 807 KAR 5:001, Section 16; an application for an alternative rate adjustment pursuant to 807 KAR 5:076; or a detailed report with supporting justification explaining why such a filing is unnecessary. Any filing for a rate adjustment filed under KRS 278.023 does not relieve Breathitt District from this requirement. 9. This case is closed and removed from the Commission's docket.
