This case is opened to investigate the alleged failure of Crittenden-Livingston District to comply with KRS 278.160 and any applicable Commission Order, including its November 4, 2025 Order as referenced herein. 2. Crittenden-Livingston District, each of its commissioners, and the general manager, in their official and individual capacities as officers of Crittenden-Livingston District's Board of Commissioners, shall submit individual, written responses to the allegations contained in this Order within 30 days of the date of service of this Order, including but not limited to any, and all written testimony or documentation that would dispute the allegations. 3. Each response shall include the name of the witness responsible for responding to the questions related to the information provided. 4. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. 5. Counsel for each party shall enter an appearance or appearances within 20 days of the date of service of this Order.
